



OVERVIEW


- Africa is the second largest continent
- 53 countries
- Approximately 800 million people
- More than 2000 languages and dialects
- An area of 30 million Square kilometers or 11.7 million square miles
- Largest continuous continent; covers more than 1/5th of the earth's total land surface

- Population of over 210 million
- Regional GDP: \$US 105.7 billion
- Sub-Saharan's largest trading bloc
- Vast untapped natural resources: gold, bauxite, zinc, uranium, manganese and phosphate
- Rich energy resources: crude oil, natural gas, coal and hydro electricity
- The world's newest emerging market

- Majority of countries qualify under AGOA
- OPIC and EXIM Bank operate in majority of countries



Why West Africa?

- Opportunity to participate in several privatizations
- Established base for numerous multinational companies

- Previous privatizations conducted to preserve transparency of process
- Positive track record of project financiability

Business Development Approach

- Africa Growth and Opportunity Act target country
- Political stability or strong sustained moves towards such stability
- Legal and regulatory frame work
- Good credit rating with support from international banking and finance institutions
- Sustained economic growth and stability
- Strong export market and diversified business

Market Selection Factors

Choosing a Country

- Repatriation of dividends and capital
- Payment in US dollars
- Ability to have on and off-shore accounts
- Licensing and consents

Key Factors

- Does it make sense?
- Will it fit, how and where with company's overall business strategy?
- Is it affordable? Is it profitable?
- Does it enjoy government support and fit policies and objectives of host country?
- Do relevant multilaterals support it?
- Who are the competitors?
- Are alliances needed or can it be done solo?




